No.F.3(23)/Fin(Rev-I)/2015-2016 .- In exercise of the powers conferred by section 102 of the Delhi Value Added Tax Act, 2004 (Delhi Act 3 of 2005), the Lt. Governor of the National Capital Territory of Delhi, hereby, makes the following rules further to amend the Delhi Value Added Tax Rules, 2005, namely:-

RULES

- 1. Short title and commencement.- (1) These rules may be called the Delhi Value Added Tax (Amendment) Rules, 2015.
 - (2) They shall be deemed to have come into force with effect from 1st April, 2014.
- 2. Amendment of rule 35.- In the Delhi Value Added Tax Rules, 2005, in rule 35, in sub-rule (2), after the proviso and before explanation, the following new proviso shall be inserted, namely:-

"Provided further that the Commissioner may admit an application for refund or an additional or a revised application for refund, as the case may be, under section 41, from the Embassies, High Commissions and International Organisations listed in the entry at serial No. 1 of the Sixth Schedule, upto a period of one year from the end of relevant quarter, subject to his satisfaction about existence of sufficient cause preventing submission of a true and correct application for refund within the time limit of three months from the end of relevant quarter."
